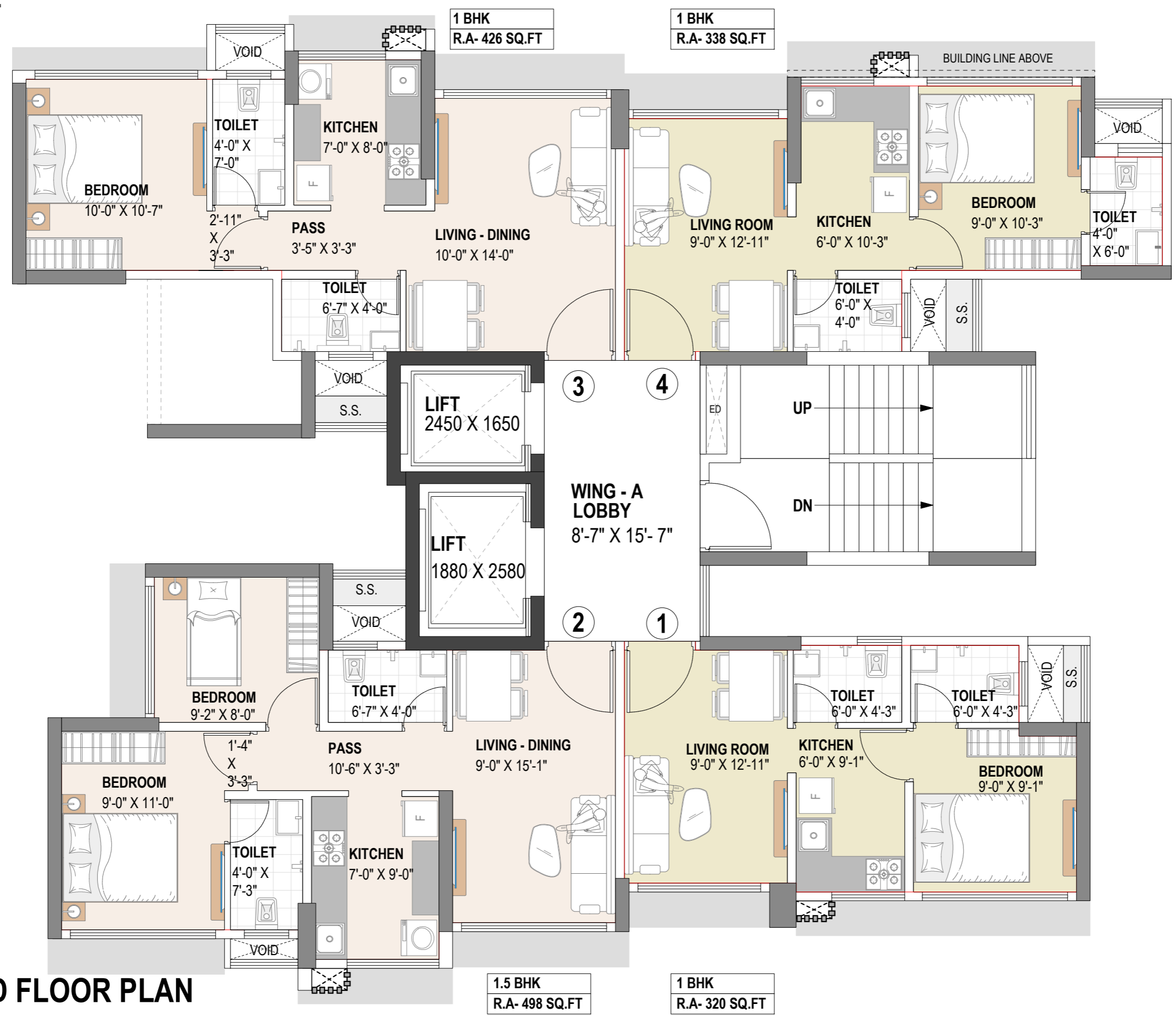

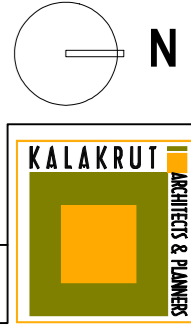


WING A 1ST, 2ND & 3RD FLOOR PLAN

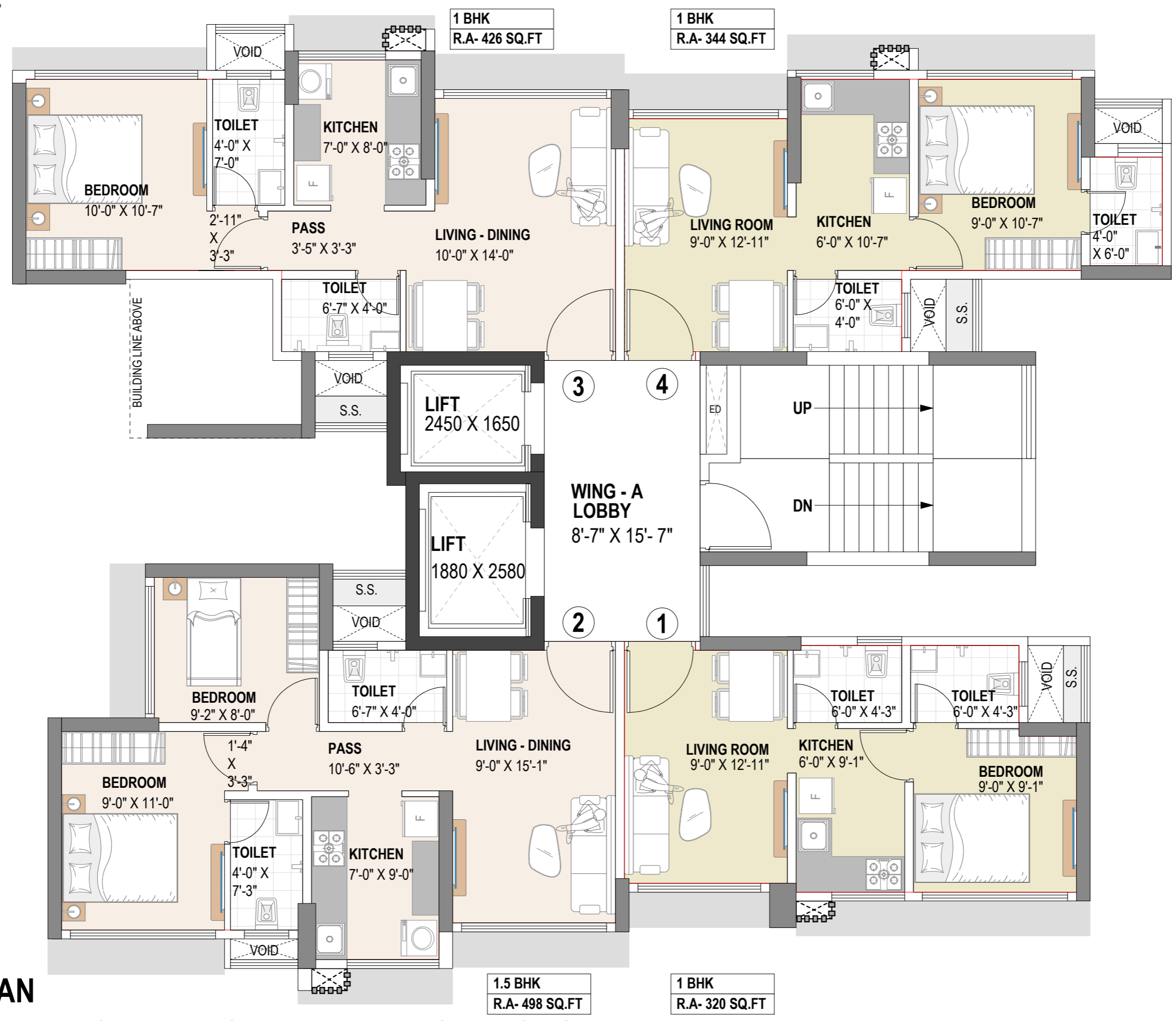

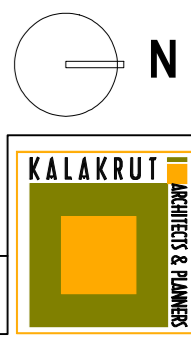


WING A 4TH FLOOR PLAN

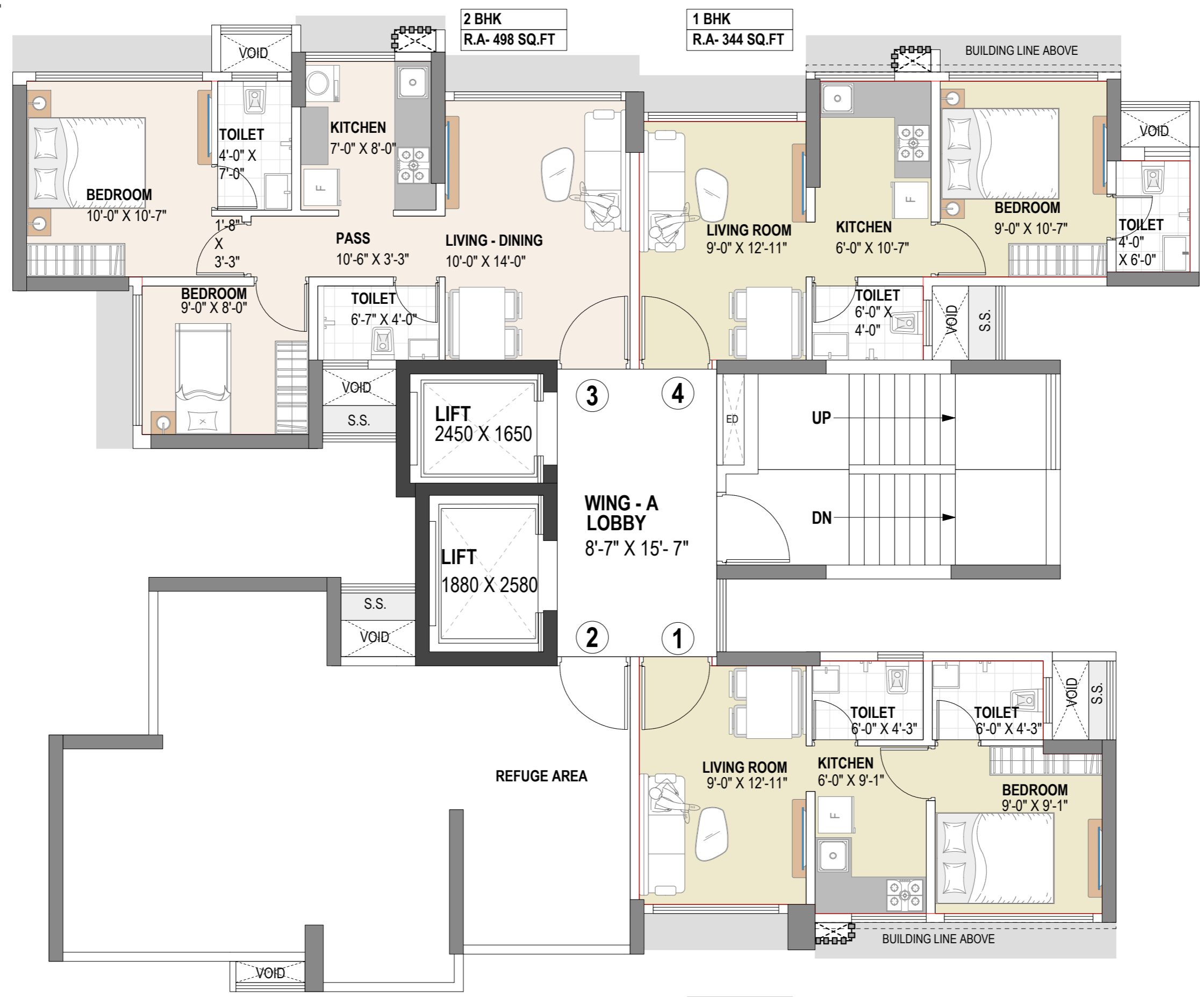

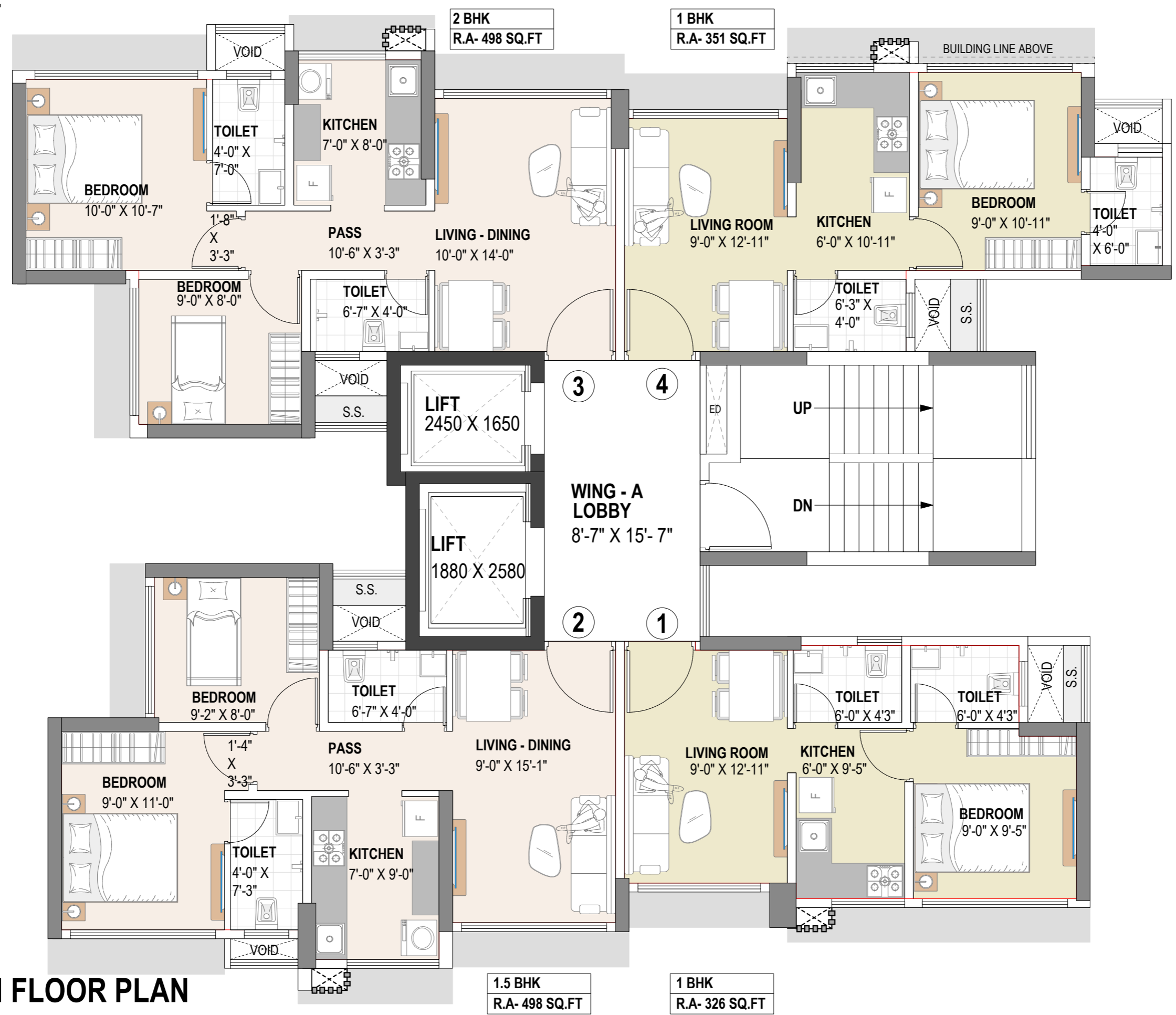

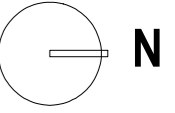

6TH, 7TH & 8TH FLOOR PLAN



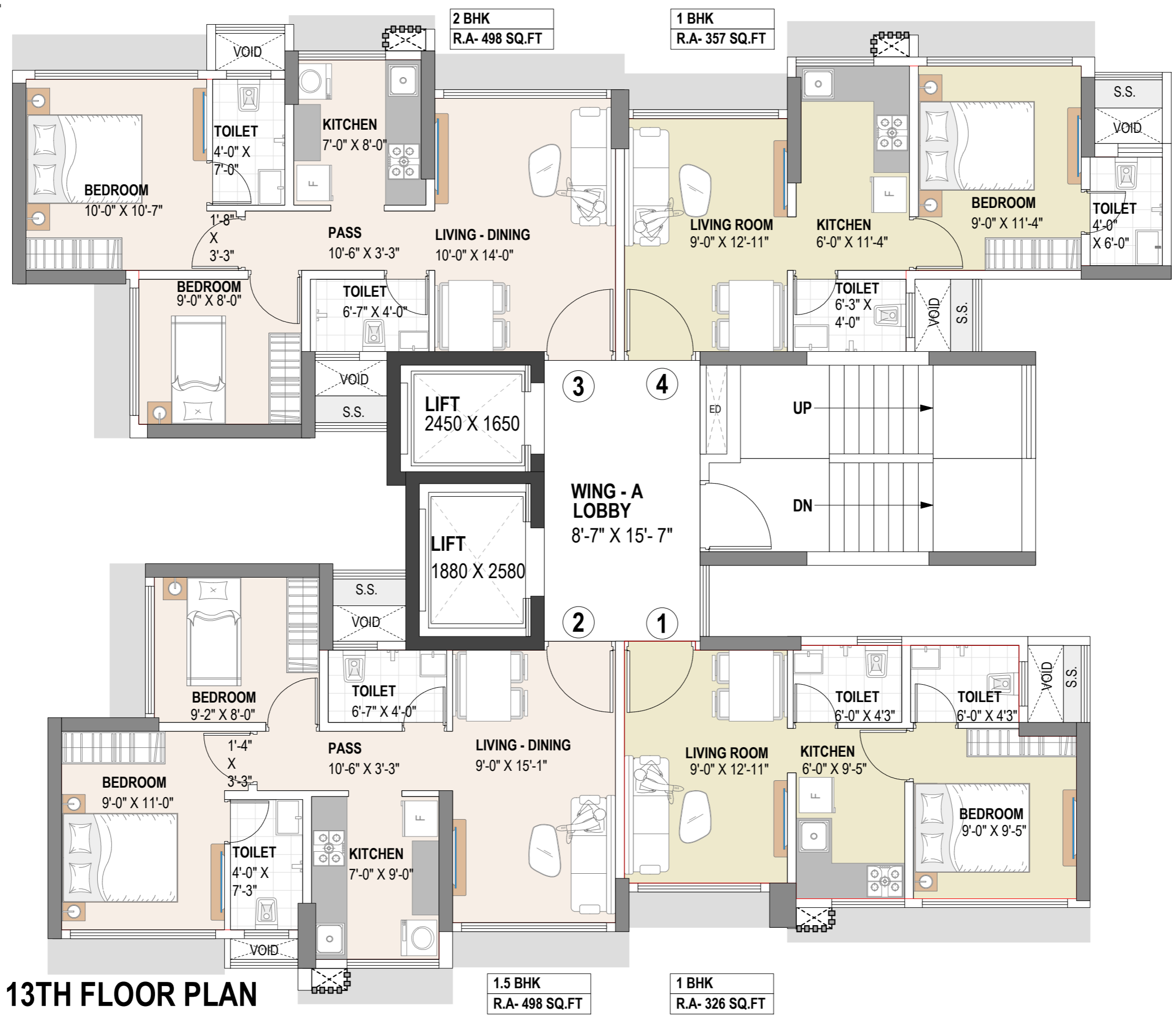

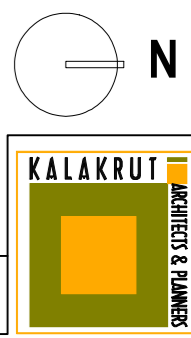

9TH TO 11TH & 13TH FLOOR PLAN

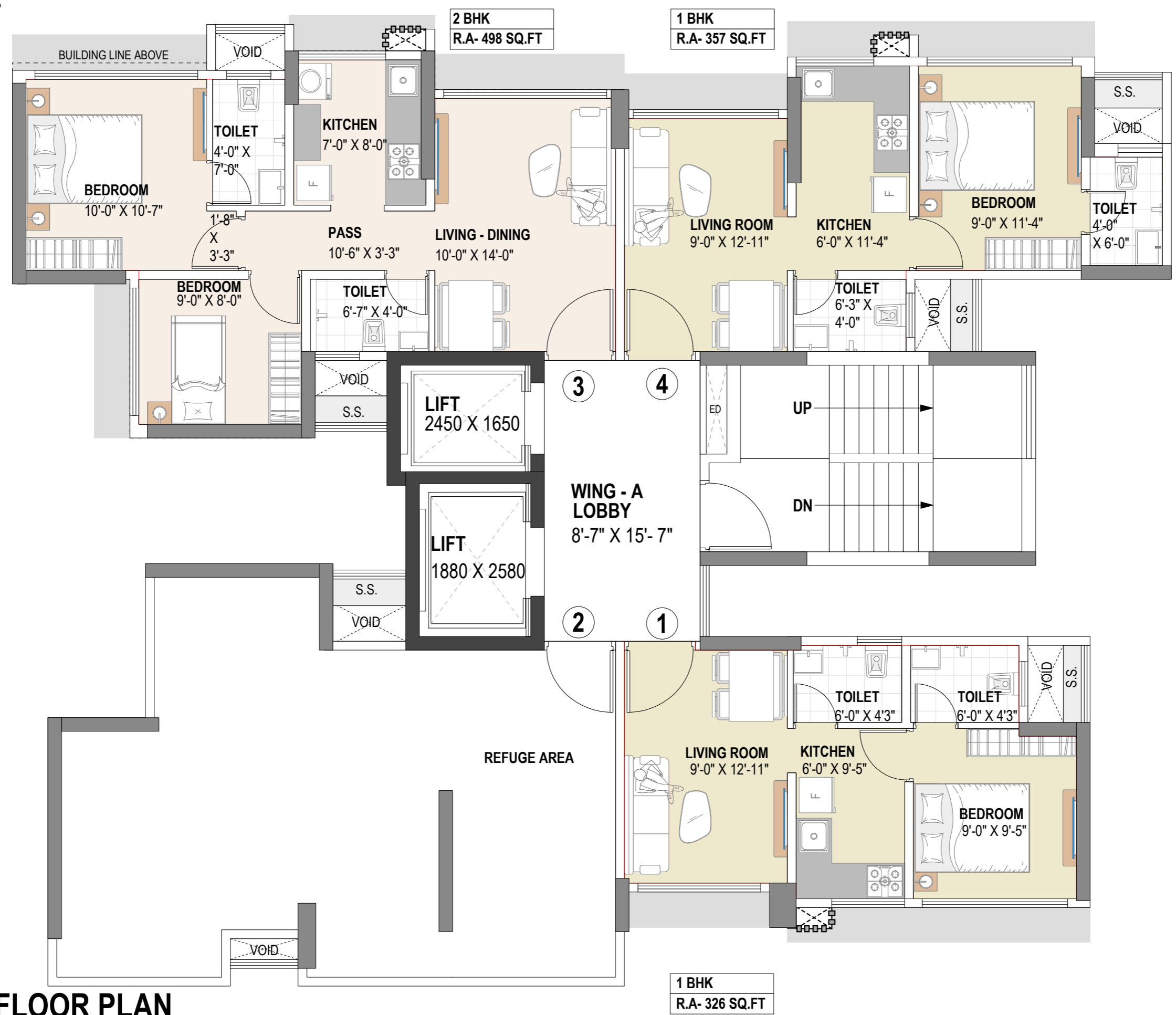

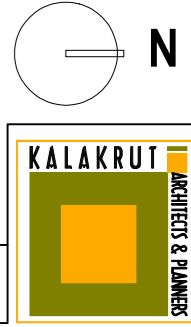


WING A 15TH FLOOR PLAN

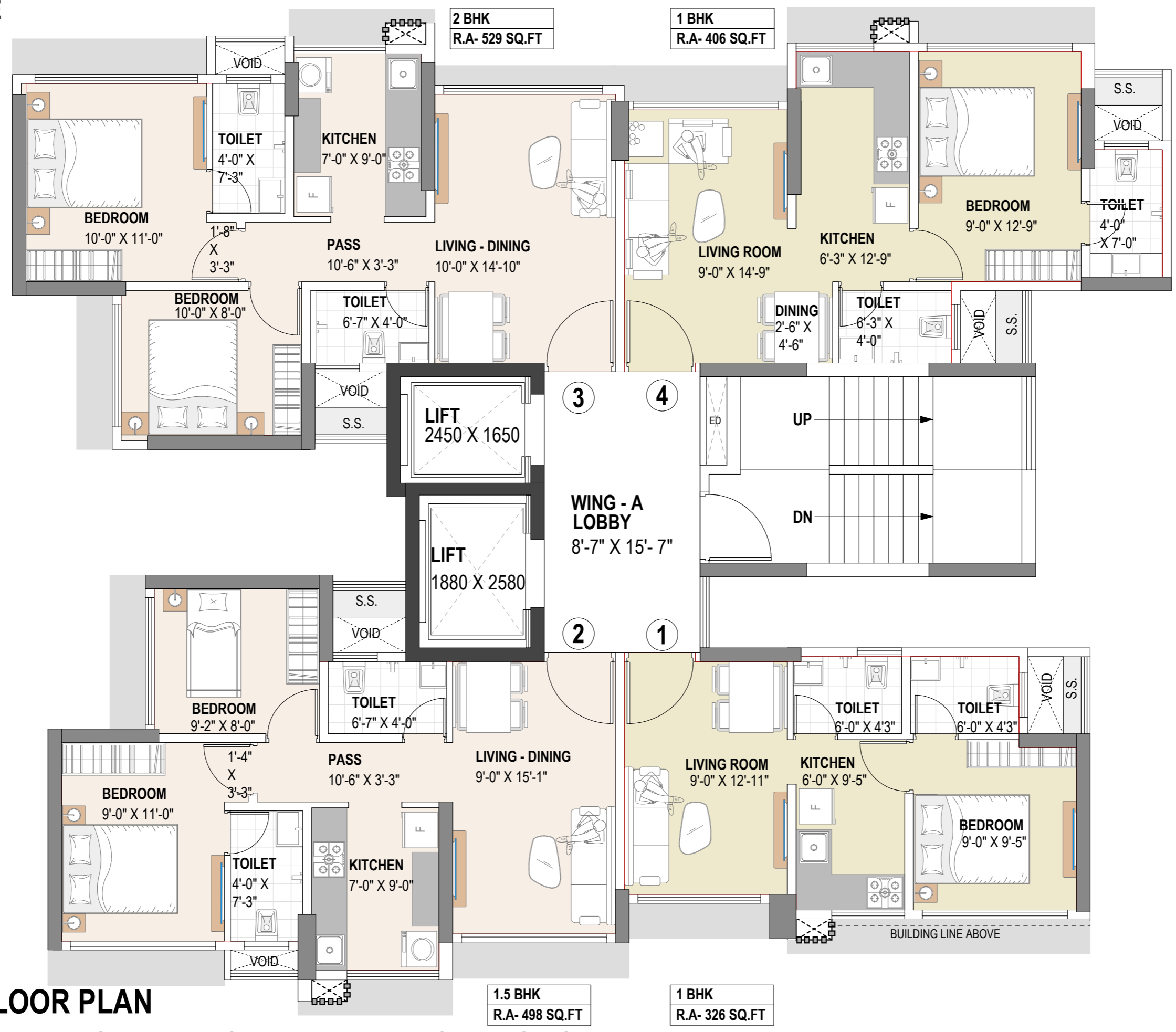

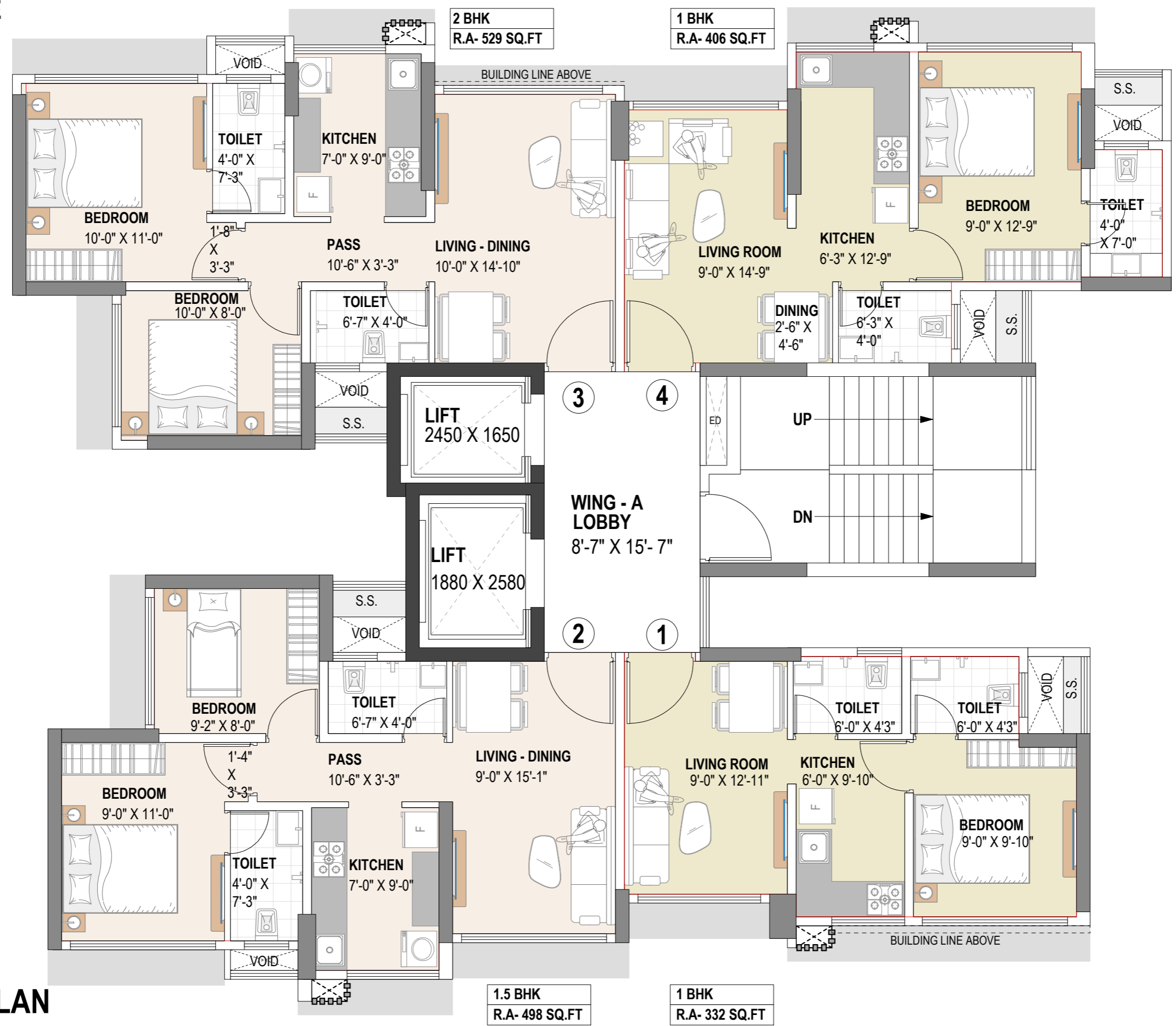

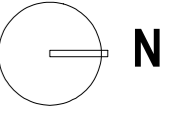


WING A 18TH FLOOR PLAN

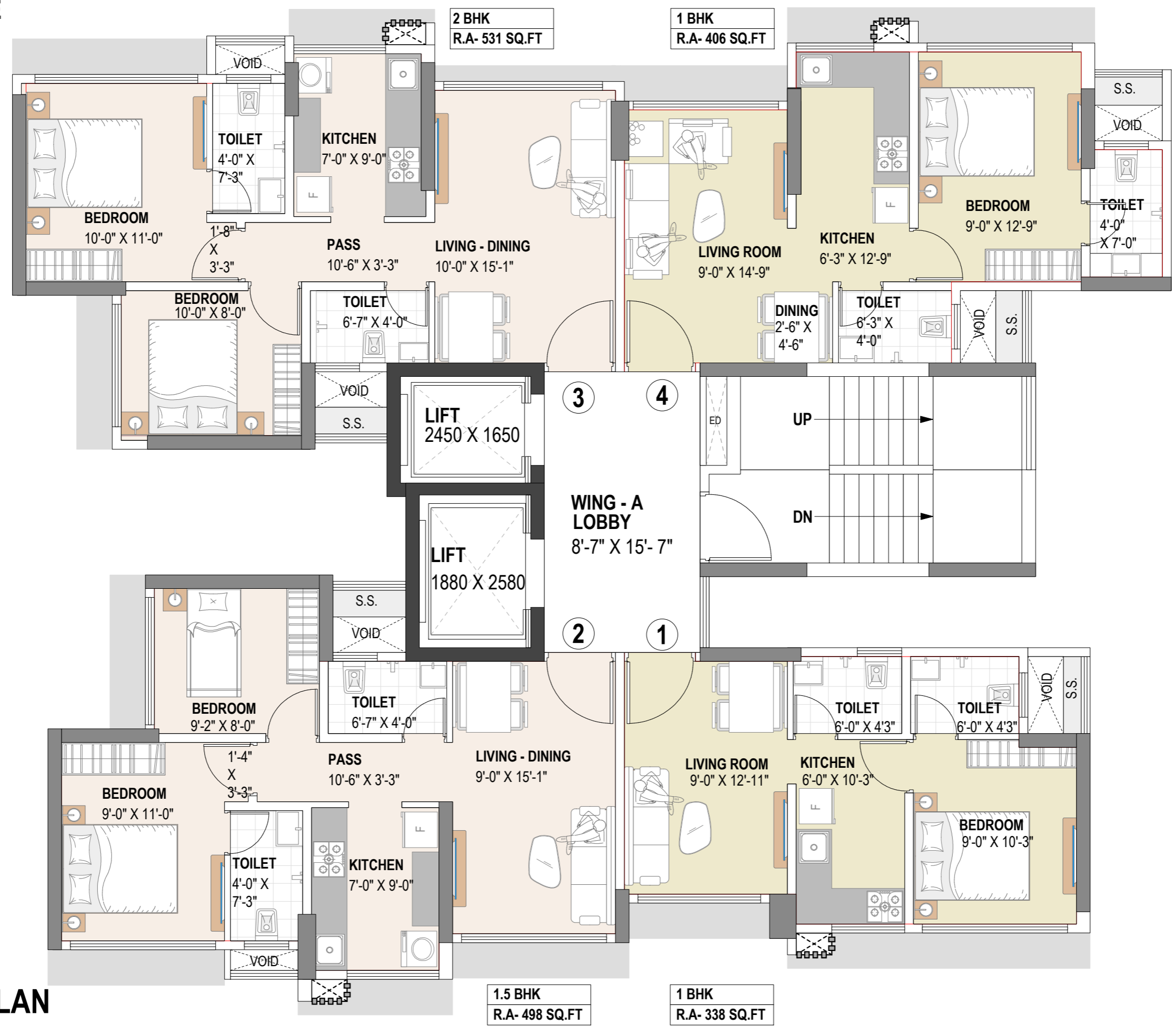
